Contrary to the claim accepted in court, they convincingly argue that a disputed fingerprint was not lifted off a drinking glass found in Inge's flat - a detail that could make all the difference. They demonstrate how blood marks on a towel could have come off the hammer, how blood stains on the floor could have been shaped by a specific shoe and how a closer look at cell phone records reveals a different choreography of movements than what was accepted by the court.
